Whatever the material or the volume, we are able to cater for all of your waste requirements, and have the staff, vehicles and site facilities to do so securely and ethically.

Our facilities allow us to sort and process the vast majority of materials ready for the next stage of re-use or recycling. Certain hazardous waste material will be contained securely before being transferred to specialist facilities for approved disposal.

Our courteous, competent and fully trained drivers can collect bags and bins at street level or from individual office floors. We also offer a bin re-line service which is carried out without any disruption to your office. Where preferred, our services can be completed outside of normal office working hours.

Our drivers will scan and record every bin which has been emptied, exchanged or re-lined providing added confidence that the service has been completed without issues.

Our support staff are always on hand to discuss your particular needs. Account Managers will have visited your site and will have comprehensive contract knowledge allowing them to make informed recommendations on improving services.

The information recorded from the scanning and weighing process allows us to highlight high-usage areas in your office as well as those which are less in demand. This enables us to tailor our service to your needs and adjust the frequency of collections to fit with your specific requirements, reducing costs and maximizing efficiency.

From the initial survey and audit, to the provision of custom-designed and branded containers, we can optimise waste streams for cost effectiveness and minimum environmental impact.

In addition to simple 'separation at source' schemes to recycle paper, plastics and cardboard, we can provide specialist services to manage confidential material, hazardous and electronic waste, and even the disposal of food for composting.

For customers unable to separate at source but still wanting to achieve substantial recycling targets, we offer an off-site Materials Recovery Facility where we are able to extract recyclable materials like cans, glass, plastics and paper products from general commingled waste.

All our recycling services are managed in-house from our East London facilities.

Security shredding



Information security management is more important than ever.

Our secure shredding service gives you the peace of mind that sensitive and confidential company information held on any media including paper, hard drives, USBs, diskettes, CDs and DVDs, credit cards and microfiche will all be destroyed in a secure and non-retrievable manner.

Under the Data Protection Act companies are also responsible for the security of personal information held digitally and on paper.

Our secure shredding service ensures that you are fulfilling these duties and that all your confidential material is being disposed of appropriately.

Our process is secure but straightforward. Confidential paper is deposited in our locked and sealed security bins. These bins are exchanged on a like for like basis and not unlocked or emptied until they have reached our destruction facility. The bin movements are tracked by a bar-code process ensuring real-time accountability from collection through to destruction.

The destruction takes place in an access controlled and CCTV monitored security unit at our depot. Where there is a preference to have the material shredded at your own site under supervision, our mobile shredding vehicle will carry this out for you.

All materials are shredded to BS EN 15713:2009. DIN 3 Category (20mm) as standard. All operatives are independently screened to BS 7858: 2006+A2 2009.

Our collection vehicles are fitted with advanced security systems and CCTV to record the loading and transportation of the bins.

Using the latest advanced tracking systems, security in transit and bar code technology we guarantee the complete security of your confidential information from the moment we collect through to its destruction.

With a detailed date and time stamped audit trail for each bin, you can be 100% sure that your confidential waste is totally secure at every stage of the process.

A certificate of destruction for each consignment collected will be your written guarantee that the destruction has been completed.

Contract Support and Reports



It is Pulse Environmental's intention to maximise the recycling performance for each customer.

By undertaking a waste audit, Pulse Environmental can identify opportunities for waste elimination, reuse and recycling. Our waste audit will determine composition and quantities of waste being generated.

However to measure the effectiveness of waste management systems accurate weights are required. Using our dynamic container weighing and identification (pay-by-weight) system, we are able to record accurately the weight of waste removed from each customer's site.

Every time a container is emptied, the time, date, GPS location and the actual weight of the material that has been collected is recorded. This information is transmitted by a hand-held PDA device to a web-based server where it is permanently stored.

Reviewing these weights will help ensure that the bins emptied or removed from site are sufficiently full to warrant collection. Our service frequencies are flexible and collections will always be tailored to suit your requirements.

The PDA device also enables pictures to be taken to document and report site specific issues, e.g. reasons for non collection, broken bins and contamination. This information along with compliance documentation and waste transfer notes / proof of collections will also be available on-line.

All the information recorded will be used to improve your services and further develop your environmental performance. Our compliance and audit team will be available to support you with waste audits, waste awareness days, toolbox talks and waste prevention & minimisation campaigns.

For the purpose of most contracts, the on-board weighing will be used for report purposes only. However, unlike most dynamic weighing systems, ours is approved and stamped by Trading Standards in accordance with the weights and measures legislation. Therefore consideration may be given to being charged by weight; giving you the financial incentive to improve recovery of recyclables.
